# **RECOMMENDED** That

- a) the definition of 'Resident' be amended to include "in a hospital, hospice, a residential care home or <u>assisted</u> living in a retirement home or village" and that the resident paragraph be forwarded to the solicitor for further guidance and that this guidance be tabled at Full Council.
- b) the definition of 'Deed' be amended to include "The Deed is subject to the regulations now in force which may hereafter be made with regards to interments in the management regulations and control of the said burial ground that are in force at the date of death and are published on the website of Burntwood Town Council" and that this paragraph also be included on the Deed document.
- c) the wording "that are in force at the date of death" be added to the 'Charges' section of the Rules and Regulations (page 8 of 8 para 2).
- d) a header be included on every page of the Rules and Regulations (Burntwood Cemetery, Rules and Regulations with effect from 21 September 2016).

- e) once approved by Full Council the approved Rules and Regulations be uploaded onto the Town Council's website.
- f) once approved by Full Council, a copy of the approved Rules and Regulations be supplied to grave and cremated remains plot owners (where appropriate) and funeral directors.
